1.1. Therapy Courses Terms and conditions updated September 4th 2019.

- 1.2. These terms and conditions (the "terms") are the basis of the contract between Therapy Courses ("us"/"we"/"our") and you. By booking a training course with us, you agree to be bound by these terms and conditions.

- 1.4. We may amend these terms from time to time. You will be subject to the terms in force at the time that you book a course with us.

2. Cancellations, Changes to Bookings and booking conditions

- 2.1. All bookings made through Therapy Courses are considered 'business to business' transactions under the scope of the Consumer Contracts (Information, Cancellation & Additional Charges) Regulations 2013
- 2.1. Training spaces are subject to availability and pre-determined class sizes.
- 2.2. Unless agreed with us in advance, full payment of all fees must be made at the time of booking in order to confirm your training place. Training dates cannot be reserved without payment and places are only considered booked once your course fee has been received.
- 2.3. Payment is only accepted by bank transfer
- 2.4. All course descriptions and prices are correct at the time of publication.
- 2.5. We reserve the right to alter course prices, content and material without notice or penalty.
- 2.6. We reserve the right to decline training applications and the provision of any related service without explanation or penalty.
- 2.7. If you cancel your booking at least 7 days before your course is due to start, you will receive a 50% refund of any fees paid.

3. Assessment and Certification

- 3.1. Delegates will be assessed by: (i) completion of in-class exercises; (ii) tutor observation of practical skills; and (iii) completion of a written test paper.
- 3.2. Certificates are issued at our discretion upon successful completion of the above assessment activities. Delegates' will have 4 months to complete a (VTCT Qualification) 3 day course. 9 months to complete the full Beauty course (VTCT Qualification). If the delegate is unable to complete the above assessment activities then additional fees will apply. One hundred pounds for half a day and two hundred pounds for one day.
- 3.3. Where a delegate's completed test paper does not demonstrate sufficient competency, that delegate may re-take this part of their assessment charged at seventy five pounds for half a day and one hundred pounds for one day.
- 3.4. Should a delegate fail the practical assessment, they will be invited to attend one further assessment at Therapy Courses charged at one hundred pounds for half a day and two hundred pounds for one day.
- 3.5. No refunds will be issued where a delegate fails to complete the training course or related assessment activities to the satisfaction of the course tutor.
- 3.6. We reserve the right to withhold certificates until all course fees have been paid in full.
- 3.7. Arrange your models for the assessment days as soon as possible. This will help you feel confident as the assessment day's approach as you know who you will be working with. Make sure you choose reliable models who you feel happy working with and with whom you have a good rapport.
